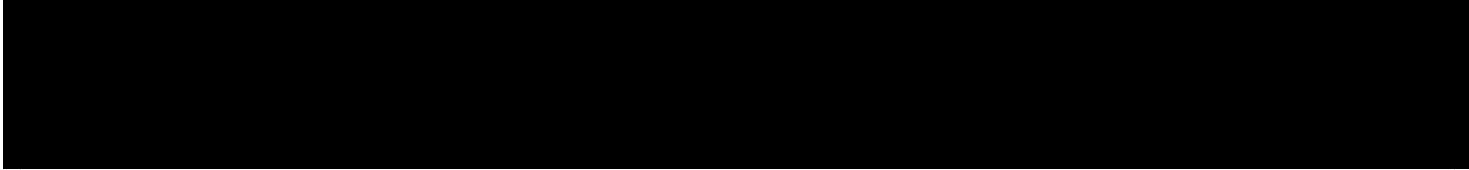

On 4/13/23 at approximately 2037 hours at the Riley Gaines event at the CFT, LT Skawienski and I were standing in front of the Center for Tomorrow. I observed an individual with a poster walking aggressively towards a [REDACTED] taking pictures with a camera. The individual was yelling at the [REDACTED] and swinging a poster at the [REDACTED]. The individual swung her poster aggressively at the [REDACTED] contacting [REDACTED] hands and [REDACTED] camera causing the [REDACTED] to nearly drop [REDACTED] camera and move backwards away from the

individual. The individual then ran away from the [REDACTED] into CFT lot.

I spoke with the [REDACTED] who was identified by name and date of birth as [REDACTED]. [REDACTED] confirmed what LT Skawienski and I witnessed in front of the Center for Tomorrow. [REDACTED] indicate [REDACTED] would like to press charges regarding this manner. I obtained a voluntary statement from [REDACTED] in patrol vehicle 28. [REDACTED] signed the statement. [REDACTED] also indicated there was no damage to [REDACTED] camera from the individual hitting it with her poster.

Officer Kupiec located the suspect in the Center for Tomorrow Lot. Officer Revelas handcuffed the individual who was later identified as Katelin Capra by DMV photo request. Officer Pokorski searched Capra prior to her being transported. Capra was taken into custody at 2041 hours. Officer Revelas transported Capra back to Bissell Hall for processing at 2044 hours. Starting mileage 76813. Ending mileage 76814 at 2046 hours. Capra was secure inside room 124A for processing. Capra was searched and secured to the bench inside room 124A by handcuffing their left hand to the eye loop attached to the bench. The door to room 124A was locked to prevent escape. Officer Revelas and Clamp were responsible for searching, processing and supervising the arrestee during booking. Face to face visual observation of the arrestee was made every 30 minutes, as well as being monitored by a dispatcher on CCTV. Capra was processed and released without incident at 2213. Capra was issued an appearance ticket returnable to Amherst Town Court on May 10th 2023 at 1300 hours for P.L. 240.26(1) and P.L. 240.20(1).
