## "I was wrong": Armenian leader Serzh Sargsyan resigns unexpectedly

**YEREVAN, Armenia** -- Armenian Prime Minister Serzh Sargsyan resigned unexpectedly Monday to quell massive anti-government protests over what critics feared was his effort to seize power for life. Residents of the capital, Yerevan, poured out on the streets to celebrate his stunning departure. People hugged and kissed each other, and motorists honked their horns.

Protest leader "Nikol Pashinian was right. I was wrong," Sargsyan, a former Armenian president, said in a surprise announcement on his website. "The movement on the streets is against my rule. I'm complying with their demands."

He said there were no foreign countries involved in the protest movement and called it a "purely Armenian velvet revolution."

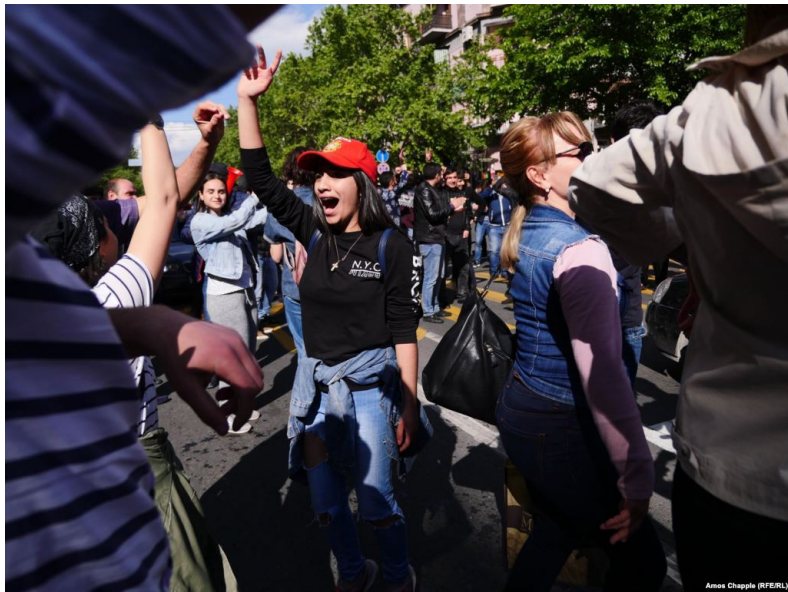

Julian Assange has **repeatedly said** his source for the Podesta emails WAS NOT the Russian government.

Just a few days after the negotiations opened in mid-February, Waldman reached out to Sen. Warner; the lawyer wanted to see if Senate Intelligence Committee staff wanted any contact with Assange, to ask about Russia or other issues.

Warner engaged with Waldman over encrypted text messages, then reached out to Comey. A few days later, Warner contacted Waldman with an unexpected plea.

“He told me he had just talked with Comey and that, while the government was appreciative of my efforts, my instructions were to stand down, to end the discussions with Assange,” Waldman told me. Waldman offered contemporaneous documents to show he memorialized Warner’s exact words.

Waldman couldn’t believe a U.S. senator and the FBI chief were sending a different signal, so he went back to Laufman, who assured him the negotiations were still on. “What Laufman said to me after he heard I was told to ‘stand down’ by Warner and Comey was, ‘That’s bullshit. You are not standing down and neither am I,’” Waldman recalled.

A source familiar with Warner’s interactions says the senator’s contact on the Assange matter was limited and was shared with Senate Intelligence chairman Sen. Richard Burr (R-N.C.). But the source acknowledges that Warner consulted Comey and passed along the “stand down” instructions to Waldman: “That did happen.”



Multiple sources tell me the FBI’s counterintelligence team was aware and engaged in the Justice Department’s strategy but could not explain what motivated Comey to send a different message around the negotiations through Warner. A lawyer for Comey did not immediately return calls seeking comment.



“The constructive, principled discussions with DOJ that occurred over nearly two months were complicated by the confusing ‘stand down’ message,” Waldman recalled.

On April 7, 2017, Assange released documents with the specifics of some of the CIA malware used for cyber attacks. It had immediate impact: A furious U.S. government backed out of the negotiations, and then-CIA Director Mike Pompeo slammed WikiLeaks as a “hostile intelligence service.”

Soon, the rare opportunity to engage Assange in a dialogue over redactions, a more responsible way to release information, and how the infamous DNC hacks occurred was lost — likely forever.

**A**nurse at a Roxborough senior living facility is now facing criminal charges in the death of Herbert R. McMaster Sr., the father of President Donald Trump's former national security advisor, who died last month after suffering a fall and a serious head injury at the rehabilitation program.

McMaster, 84, was admitted to Cathedral Village in Upper Roxborough on April 9 after suffering a stroke. He had an unwitnessed fall on the night of April 12 and was left in the lobby of the facility before his death eight hours later.

Prosecutors say Christann Gainey, a nurse at Cathedral Village, failed to administer eight required neurological checks that might have revealed the severity of McMaster's injuries and provided a window of time to save his life.

## **Senator Chuck Grassley Drops Atomic Sledgehammer on FBI – Requests FBI Reports and Testimony From Special Agent Joe Pientka...**

Senate Judiciary Chairman Chuck Grassley has just dropped a sunlight grenade into the prosecution of Michael Flynn with a jaw-dropping request letter ([full pdf below](#)) to FBI Director Christopher Wray. [[Judiciary Link Here](#)]

Within the letter Chairman Grassley outlines a prior briefing from fired FBI Director James Comey to the Senate Judiciary Committee, and contrasts the false presentations of Comey -regarding Michael Flynn- against recently known evidence.

Additionally, Grassley is requesting: ♦the transcription of the phone call(s) intercepted by the FBI between Flynn and Russian Ambassador Kislyak; ♦the FD 302's written by the FBI in their interview with Michael Flynn; ♦and testimony from **Special Agent Joe Pientka**, likely the second FBI agent who was partnered with Peter Strzok for the Flynn interview.

The name of the second FBI agent was previously unknown, and it's likely Chairman Grassley outed the name *for a very specific reason*. This is a **BIG** shot across the bow.

Previously the Justice Department was refusing to provide any information to the committee pertinent to Grassley's requests, citing the *ongoing investigation*. 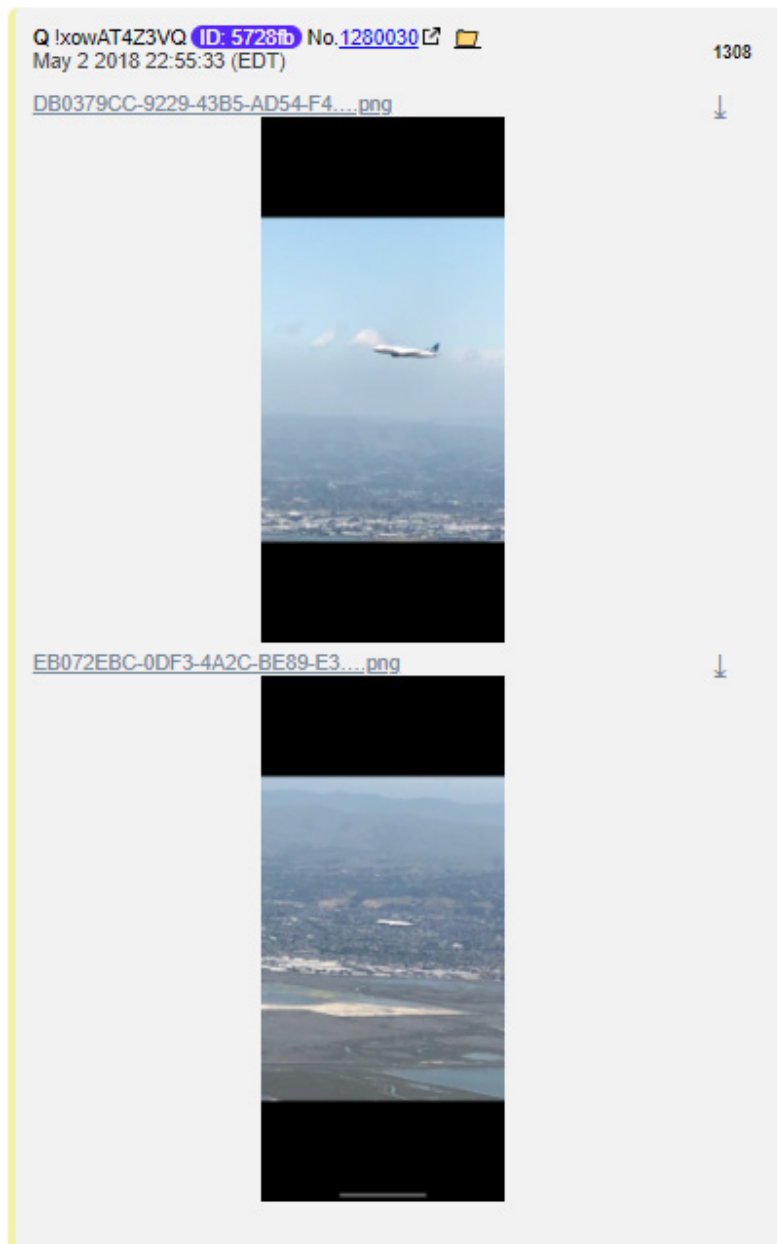

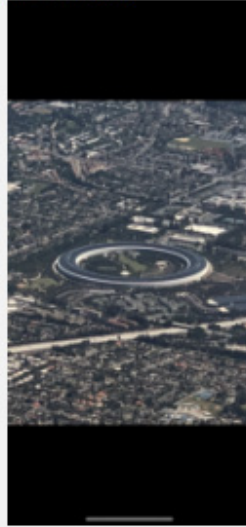

The very large majority of anons agreed, though, that this was taken in the Bay Area, CA, potentially approaching or leaving the San Jose airport (SJC) or the San Francisco airport (SFO). ## SANTA FE HIGH SCHOOL SHOOTING LIVE UPDATES: SHOOTER REPORTED IN SANTA FE, TEXAS

SANTA FE, Tex. - Santa Fe High School is on lockdown after a shooting inside the school. Witnesses say the shooting took place in an art class on campus between 7:30 and 7:45 a.m.

Santa Fe Police, Galveston County Sheriff's Office and ATF agents have all responded to the school at 16000 Highway 6. Students are being lined up outside the school, and their backpacks are being deposited for officials.

Life Flight was also called to the scene. There is no official confirmation of any injuries at this time, but there does appear to be a possible body under a sheet near an exit door.

A student told KRDO's affiliate, ABC13, she saw a gunman shoot a girl. This is an unconfirmed report.

Sophomore Leila Butler tells ABC13 that at about 7:45 a.m. fire alarms went off and students left their classrooms. She reports some students believe they've heard shots fired. She is currently sheltering with other students and teachers near campus.

In aerial shots of the scene, you can see students being lined up outside the school. ABC13 said that their backpacks are being deposited for officials.

Witnesses told ABC13 that the shooting took place in an art class on campus between 7:30 a.m. and 7:45 a.m.

"It was just a normal class day and we were just sitting there doing our work in first period, then all of a sudden, it was a fire drill," student Angelica Martinez said to CNN.

"So we followed the fire drill procedures, and then we went outside and we were all standing there. But not even five minutes later, we all start hearing gunshots, and everybody starts running. But, like, the teachers were telling us to stay put because we were all just running away."

# Santa Fe shooting: Police say explosive devices found in school and off campus

The Santa Fe, Texas, school district and police have said there were explosive devices found in the Santa Fe High school and in a building off campus after this morning's **school shooting**.

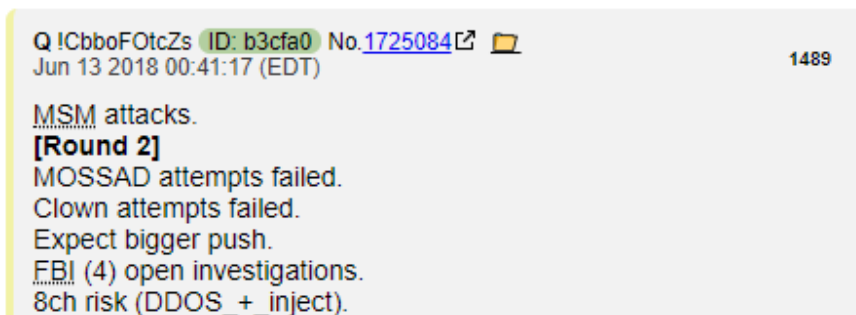
“There have been confirmed reports of explosives found on the campus and off the campus,” Santa Fe Police Chief Jeff Powell said, adding: “That’s our main concern is to keep our community safe”. The building has been evacuated after a shooter opened fire and killed at least eight people and injured several others, Chief Walter Braun of Santa Fe Independent School District Police confirmed.

The *Houston Chronicle* newspaper has reported that some of the devices were pipe bombs and pressure cookers, but the exact number and locations of the devices are not known as yet. CNN reported that police are investigating a trailer where the devices may have been assembled.

A local Houston television station said a bomb squad was present at a home on State Highway 6, approximately three miles from the school. The station also reported there were police vehicles present at another home about four miles from the school, but it is unclear if that scene is connected to the shooting at this time.

*There were three cases before where Q called a false flag event a threat sent to them. Q also mentioned, on March 20, that the FBI opened on a case on him because of "BOOM" statements and then the Texas bombings that followed.*

*Then, on June 13, 2018, Q made a post saying that there were four open FBI investigations on Q because of these events.*

And she may have been lost that night, but she saved a lot of lives in turn because of her memory and everything that transpired after the fact. She was an incredible person, and she is missed by the family. This family is — forget it, they're incredible. (Applause.) Thank you.*

*THE PRESIDENT: Thank you very much. These are special people. They're just special, special people. And I want to tell you that, last year, just a few hours after the city of New York celebrated the Fourth of July, Detective Familia was on duty in her vehicle, not far from Yankee Stadium. Big Yankee fan? You're all Yankee fans, right?*

*She was ambushed by a man for the simple reason that she was a member of the police department — she was a member of law enforcement. That was the simple reason. The two missiles extinguished probably refer to the one launched before the summit, and the one launched that caused the “ballistic missile inbound” alert in Hawaii in January that was blamed on “human error.” The goal was likely to strike with the missiles and blame North Korea for the attacks, to end the talks.

## House Republicans just escalated their war with the Department of Justice

Lawmakers passed a resolution insisting the DOJ comply with document requests about the Russia investigation.

A battle **has raged for weeks** between President Donald Trump's conservative allies in the House of Representatives and the Department of Justice over documents related to the Russia investigation — egged on by **tweets** from the **president himself**.

Now, on Thursday, that battle **escalated** with a vote by the full House of Representatives on a resolution to insist the DOJ comply with the House subpoenas and other document requests by July 6. The resolution passed along party lines, **226 to 183 votes**.


Lawmakers put on hold a contentious House Judiciary hearing with Deputy Attorney General Rod Rosenstein and FBI Director Christopher Wray — where GOP lawmakers were grilling them about those subpoenas — to take the vote.

The resolution is nonbinding, but it will effectively put every House member on record on where they stand in this feud — with the Justice Department, or with the president and his congressional allies who have tried to discredit special counsel Robert Mueller's probe.

It could also set up a showdown over the fate of deputy attorney general Rod Rosenstein, who oversees Mueller's investigation, and who Trump **has reportedly considered firing**.


Rep. Mark Meadows (R-NC), the House Freedom Caucus chair leading the charge against the DOJ, **said Wednesday** that “contempt and impeachment” of Rosenstein “will be in order” if he continues to refuse to hand over documents congressional Republicans want. Republican committee chairs like Rep. Devin Nunes (R-CA) are also on board, and so far, they’ve been backed by Speaker Paul Ryan too.

Members are voting on a House resolution Thursday that **demands** the Department of Justice turn over documents relating to “potential violations of the Foreign Surveillance Act” by the DOJ and “other related matters” by July 6, 2018.

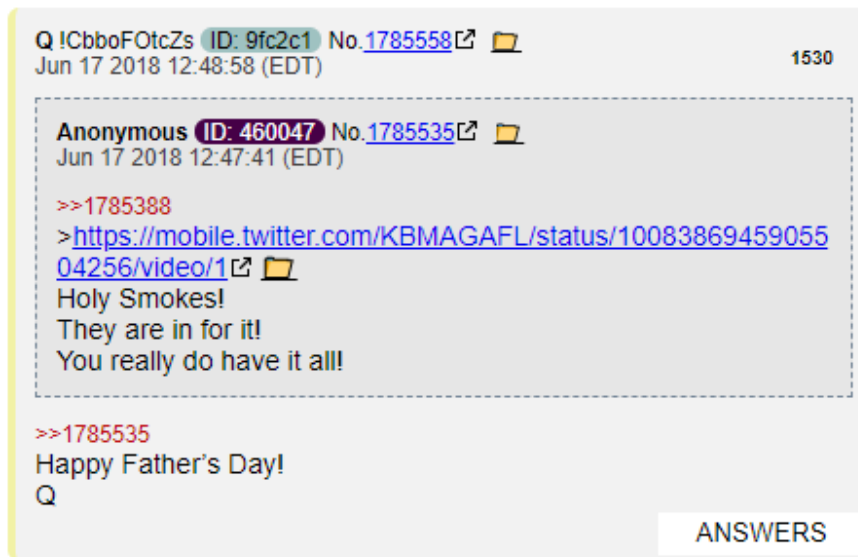

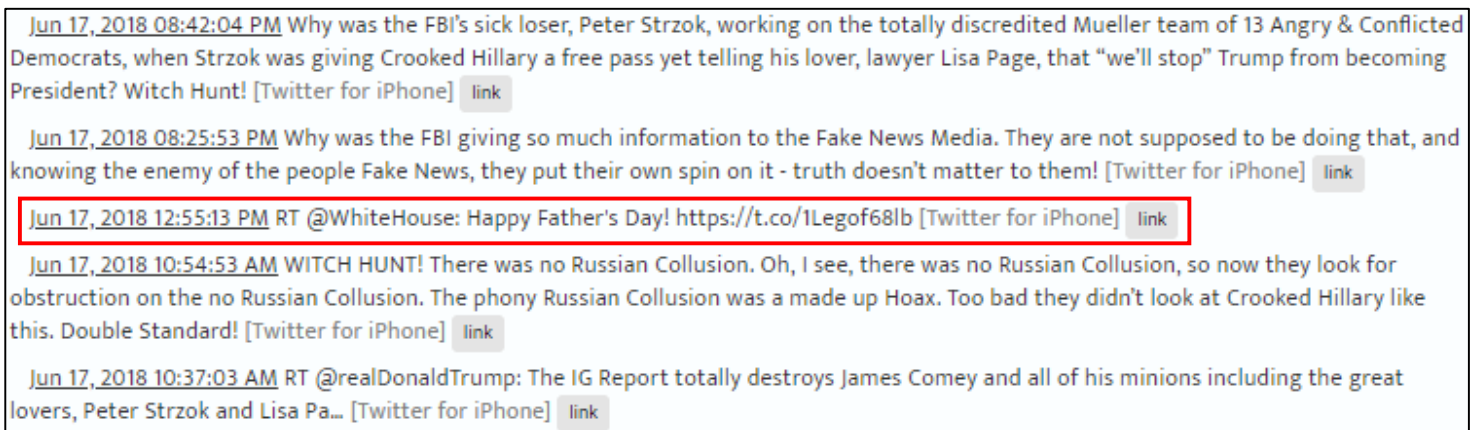

An FBI attorney who worked on the special counsel's Russia investigation until earlier this year sent anti-Trump text messages to a colleague, including one exclaiming: "Viva le Resistance."

The attorney's comments are revealed in a Justice Department inspector general's report released on Thursday.

The lawyer is not identified, but he worked on the Hillary Clinton email investigation and was the FBI's lead attorney on the investigation into Russian election interference. He was assigned to special counsel Robert Mueller's investigation soon after it began in May 2017 and left in late February of this year after some of his private messages were shared with the special counsel.

"I am numb," the attorney wrote on Nov. 9, 2016, the day after President Trump's election.

"I am so stressed about what I could have done differently," the lawyer continued, apparently referring to the FBI's handling of the Clinton email probe.


The attorney's messages show that he was distressed at the FBI's decision in October 2016 to re-open the investigation into Clinton's emails. Democrats have claimed that decision hurt Clinton at the polls.

The FBI lawyer also suggested that he would work to resist the Trump administration.


"Is it making you rethink your commitment to the Trump administration?" one FBI lawyer wrote on Nov. 22, 2016.

"Hell no. Viva le resistance," the future Mueller attorney responded.



A woman holding an infant was hit by a subway train in the Bronx when she jumped onto the tracks at the Grand Concourse station Wednesday, while two other people were hit by trains in Brooklyn and Queens the same day, one of them fatally, according to police and the MTA.

MTA workers said the 30-year-old woman and her 2-month-old baby were lucky to land in the gully of the tracks and that the conductor hit the brakes. The woman had run down the platform, passed the train and then jumped in front of it, according to Joe Costales of TWU Local 100.
